Should not have been subject to a disciplinary punishment as per the provisions set out in the Public Service Commission Circular No. 01/2020

### 20.2.2 Promotion to Grade II from Grade III

- (a) Section 20.2.2 of the *Gazette Extraordinary* No. 2164/13 dated 25.02.2020 is applicable.
- (b) Following provisions are applicable to the officers who had satisfied the qualifications required to be promoted to Grade II on or before 05.07.2021 in terms of the provisions of the previous Service Minute but have not been promoted to Grade II before the said date.

The active and satisfactory period of service up to 05.07.2021 from the date on which the officer completed the qualifications required to be promoted to Grade II in terms of the provisions of the previous Service Minute is considered as an active and satisfactory period of service in Grade II when promoting to Grade I.

### 20.2.4 Promotion to Supra Grade from Grade I

- (a) Officers who have been promoted to Grade I before 05.07.2021, the effective date of 09th amendment to the Service Minute are promoted to Supra Grade with effect from the date of completion of an active and satisfactory service period of 07 years in Grade I considering the qualifications given under 10.3.1 except the qualification (i) given there under.
- (b) Officers who have completed 07 years in Grade II before 05.07.2021, the effective date of 09th amendment to the Service Minute are promoted to Supra Grade with effect from the date on which he/ she completes an active and satisfactory cumulative service of 22 years in the Nursing Service including the active and satisfactory service period of 07 years in Grade I considering the qualifications given under 10.3.1 except the qualifications (i) given there under.
- (c) The active and satisfactory Period of service of more than 07 years in Grade I of the officers who were promoted to the Supra Grade Class on or before 05.07.2021, the effective date of the 09th amendment to the Service Minute, shall be treated as the period of service in the the Supra Class subject to a maximum period of 03 years. However, there will be no change in the date of promotion to the Supra Class in terms of these provisions.
