IT is hereby informed that under Sub-section (1) of Section 07 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the government intends to acquire the following lands required for a public purpose.

Description of the Lands to be Acquired:
