PORTS AND AIRPORTS DEVELOPMENT LEVY ACT, No. 18 OF 2011

Order under Section 3

BY virtue of the powers vested in me by Sub-section (3) of Section 3 of the Ports and Airports Development Levy Act, No. 18 of 2011, I, Ranil Wickremesinghe, Minister of Finance, Economic Stabilization and National Policies do hereby this Order, amend Schedule IV of the *Extraordinary Gazette Notification* No. 2312/67 dated December 31, 2022 by addition to the said Schedule of the Articles specified in Column III corresponding to the HS Headings and HS Codes specified in the Column I and II as exempted in Column IV of the Schedule hereto.

This Order shall come in to effect from April 04, 2023.
