Amendment of Judicial Service Commission Rules

IT is hereby directed that the eligibility criteria/qualifications published under Government Notifications in *Extraordinary Gazette* No. 2024/45 dated 23rd of June 2017 of the Democratic Socialist Republic of Sri Lanka which replaced the eligibility criteria/qualifications referred to under “appointments, promotions and transfers of Judicial Officers” in paragraph 06 in part II of rules of the Judicial Service Commission published under Government Notifications in *Gazette* No: 14 dated 08th of December 1978 of the Democratic Socialist Republic of Sri Lanka is hereby replaced by substituting the under mentioned eligibility criteria/qualifications as per the directions of the Judicial Service Commission.

Post of Judicial Officer Class II Grade I (Magistrate) in Sri Lanka Judicial Service

Eligibility :-

- (a) a President of Labour Tribunal whose period of service as such President, Labour Tribunal is not less than two years;
- or
- (b) an Attorney-at-Law who has or had been in active practice for not less than four years;
- or
- (c) an Attorney-at-Law who has served in the capacity of a Legal Officer/Legal Research Officer in any Ministry or Government Department, State Corporation or any other State Institution for not less than four years;

- (d) an Attorney-at-Law who has served in the capacity of a Legal Officer in any Firm, Bank or Establishment for not less than four years and who has regularly appeared before court during such period.

N.B: in computing the period of service/active practice of "not less than four years", referred to in paragraphs (b), (c) and (d) above, combination of periods of service/active practice under (b),(c) and (d) above would be considered.

Post of President Labour Tribunal Grade II

Eligibility :-

- (a) an Attorney-at-Law who has or had been in active practice for not less than four years;

or

- (b) an Attorney-at-Law who has served in the capacity of a Legal Officer/Legal Research Officer in any Ministry or Government Department, State Corporation or any other State Institution for not less than four years;

or

- (c) an Attorney-at-Law who has served in the capacity of a Legal Officer in any Firm, Bank or Establishment for not less than four years and who has regularly appeared before court during such period.

N.B: in computing the period of service/active practice of "not less than four years", referred to in paragraphs (a), (b) and (c) above, combination of periods of service/active practice under (a),(b) and (c) above would be considered.
