##### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Notice under Section 07

*Reference No. : RAT/LAN/10/FI/07.*

I, hereby give notice under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following land/servitude right which is required for a public purpose.

*Description of the Land / Servitude right to be Acquired :*

All that allotment of land in total extent of about 0.0275 Hectares, depicted as lot 207 in the Cadastral Map No. 521003/09/46/1 and dated 05.10.2022, prepared by the Surveyor General, situated at Vihara Grama Niladhari Division, No. 546 B, within Dehiwala Mount Lavinia Municipal Council Limits, in the Divisional Secretary's Division of Ratmalana in Colombo District, Western Province and bounded as follows.
