TOWN AND COUNTRY PLANNING ORDINANCE (CHAPTER 269)

Order under Section 6(2)(b) and Section 21(2)(b)

BY virtue of the powers vested in me by Section 6(2)(b) and Section 21(2)(b) of the Town and Country Planning Ordinance (Chapter 269), I, Prasanna Ranatunga, Minister of Urban Development and Housing do by this Order—

- declare that the area of land called “Kirimatiyana Sri Sudhammawansharama Maha Viharaya” specified in the Schedule hereto shall be an urban development area for the purpose of the aforesaid Ordinance; and
- direct that an outline physical plan shall be prepared for the “Kirimatiyana Sri Sudhammawansharama Maha Viharaya” which is declared as above to be an urban development area.

SCHEDULE

THE AREA OF LAND COMPRISING KIRIMATIYANA SRI SUDHAMMAWANSHARAMA MAHA VIHARAYA

All that area of land containing in an extent of 7.6804 hectares comprising the Lot No. A land called “Viharawatta Delgahahena Thekkawatta Pinkubura” as depicted in Survey General’s Tracing No. PU/DSO/2019/414 and dated 15th January 2020, situated in the Village of Kirimatiyana within the Minor Division of Pitigal Koralaye South, within in the Divisional Secretariat Division of Dankotuwa in the District of Puttalam in the North Western Province and bounded as follows:-
