THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 07

I, hereby give notice under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government has acquired the allotment of land to create a lake in the allotments of marshy lands called Maha Kumbura and Kiththampahuwa located adjacent to Vivekarama Mawatha, Wellampitiya under Kolonnawa Storm Water Drainage and Environment Improvement Project.

Description of the Land to be Acquired :

Three (03) allotments of Land in total extent of 1.4323 Hectares, depicted as Lot Numbers 01, 02 and 03 in the

preliminary plan No. Co. 10036 dated 08.03.2023 prepared by the Surveyor General, situated in village called Wellampitiya in the Grama Niladhari Division No. 508 of Kiththampahuwa in the Divisional Secretary's Division of Kolonnawa in Colombo District, Western Province and bounded as follows.
