TOWN AND COUNTRY PLANNING ORDINANCE (CHAPTER 269)

Order under Section 6(2)(b) and Section 21(2)(b)

BY virtue of the powers vested in me by Section 6(2)(b) and Section 21(2)(b) of the Town and Country Planning Ordinance (Chapter 269), I, Prasanna Ranathunga, Minister of Urban Development and Housing do by this Order :-

- (a) declare that the areas of lands called "Pilakatumulla Sri Pushparama Purana Viharaya" specified in the Schedule hereto shall be an urban development area for the purpose of the aforesaid Ordinance ; and
- (b) direct that an outline physical plan shall be prepared for the "Pilakatumulla Sri Pushparama Purana Viharaya" which is declared as above to be an urban development area.
