#### STATEMENT OF MATTER IN DISPUTE

#### The matter in dispute between the aforesaid parties is -

Whether Mr. S. A. Kamalasena who worked at the Pelwatta Unit of Lanka Sugar Company (Pvt) Ltd. had been caused injustice by the following matters and if so, to what relief he is entitled:

- Appointing Mr. S. A. Kamalasena who served as the Acting Deputy General Manager (Human Resources) of the Sevanagala Unit of Lanka Sugar Company (Pvt) Ltd. for 16 months to the permanent post of Manager - HR and transferring him to the Pelwatta Unit of the Company,
- 2. Deprival of all allowances and previleges granted to him as the Manager (Human Resources) of the Sevanagala Unit of Lanka Sugar Company (Pvt) Ltd. from 01.10.2016 in transfering him to the Pelwatta Unit of the Company from 08.05.2018,
- Appointment of other officers from time to time for the permanent post of Deputy General Manager (Human Resources) post of Pelwatta Unit of Lanka Sugar Company (Pvt) Ltd. post on acting basis and not appointing Mr. S. A. Kamalasena to the said DGM (HR) Post if he has the qualifications.
