I, hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by Land Acquisition Act, No. 28 of 1964, that the Government intends to acquire the following land/servitude which is required for a public purpose:

Description of the land/servitude Transferred to the Government:
