THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Nalaka Jude Harin Fernando, the Minister of Tourism and Lands do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The Allotments of land in total extent of 6.1314 Hectares, depicted as Lots A, B, C, D, E, F, G, H, J in the Advance Tracing No. VA/VAV/2022/53 dated 28.06.2022, prepared by the District Superintendent of Surveyor, situated in the Village of Karuvalpuliyanakulam in the Grama Niladhari Division of Kaatharsinnakulam in the Divisional Secretary's Division of Vavuniya in Vavuniya District in Northern Province and bounded as follows:
