**SPECIAL COMMODITY LEVY ACT, No. 48 OF 2007**

**Order under Section 2 and Section 5**

1. BY virtue of the powers vested in me under Section 2 of the Special Commodity Levy Act, No. 48 of 2007, I, Shehan Semasinghe, Acting Minister of Finance, Economic Stabilization and National Policies of the Democratic Socialist Republic of Sri Lanka, do by this order impose in respect of the commodity specified in Column I of the Schedule hereto a Special Commodity Levy at the rate specified in the corresponding entry in Column II of that Schedule.

2. By virtue of the powers vested in me by Section 5 of the Special Commodity Levy Act, No. 48 of 2007, do hereby make an Order to waive-off;

- (i) balance amount after collecting Rs. 200 per Kg. from the applicable Special Commodity Levy of Rs. 1,300 per Kg. on importation of Frozen Whole Egg Liquid, classified under the HS Code of 0408.99 as listed out in the Schedule above on recommendation of the Secretary, Ministry of Trade, Commerce and Food Security subject to approved quantity and applicable rules and regulations, and;
- (ii) balance amount after collecting Rs. 275 per Kg. from the applicable Special Commodity Levy of 10% or Rs. 400 per Kg. on importation of fish classified under the HS Heading 03.03 by Order published in the *Extraordinary Gazette* Notification No. 2301/40 of October 13, 2022 in respect of fish varieties, classified under the HS Codes as specified in the table below on the recommendation of the Secretary, Ministry in charge of subject of Fisheries.

3. This Order shall be valid for a period of three (3) months commencing from 23rd June, 2023 subject to provisions of Sub Section (3) of Section 2 of the Special Commodity Levy Act, No. 48 of 2007.
