The Sri Lanka Bureau of Foreign Employment Regulations 1985, published in the *Gazette Extraordinary* No. 364/9 of August 28, 1985, as amended by the regulations published in the *Gazette Extraordinary* No. 1765/21 of July 6, 2012 are hereby further amended by the repeal of paragraph (b) of regulation 2 thereof and the substitution therefor of the following :-

“(b) for each renewal of the license in respect of the same premises

Rs. 100,000.00”

Order under Section 51

BY virtue of the powers vested in me by Section 51 of the Sri Lanka Bureau of Foreign Employment Act, No. 21 of 1985, I, Manusha Nanayakkara, Minister of Labour and Foreign Employment, do hereby this Order, determine that every person recruited for employment outside Sri Lanka and falling into the category of employment specified in Column I of the Schedule hereto, shall pay the Bureau the sum specified in the corresponding entry in Column II of that Schedule

SCHEDULE

<i>Column I</i>	<i>Column II</i>
(a) Category where the employee has entered into a contract with an employer for the first time	Rs. 18,000/- (Subject to applicable taxes)
(b) Category where the employee has renewed the contract with the same employer for the second or subsequent time	Rs. 3,600/- (Subject to applicable taxes)
