Local Government Notifications

PRADESHIYA SABHA - PANDUWASNUWARA

TO be read with Section 24 of the Pradeshiya Sabha (local councils) Act, No.15 of 1987.In accordance with the work assigned to the Pradeshiya Sabhas (local councils) of the North Western Province in the series of "orders on the preparation of plans and listing of roads and narrow paths maintained by the Pradeshiya Sabhas (local councils) of the North Western Province" published by the Honorable Governor of the North Western Province in the *Extraordinary Gazette* No. 2238/35 and dated July 30, 2021 and the *gazette* announcement dated 27.12.2022 No. 2312/10. In terms of Section 9(3) of the said local council act, it is hereby announced for the public's knowledge that it has been resolved at the decision No. 177 on 20.04.2023 that all the roads and narrow paths maintained by Panduwasnuwara Pradeshiya Sabha that are stated in the sub section given below should be declared as roads and narrow paths owned by Pradeshiya Sabha (local council).

If it is the opinion of the party claiming the said land that any road or narrow path included in the said schedule passes through any land or enters into any part of any land, a suit in a competent court be filed before the expiry of a period of three months from the date of this notification to prove his right to such land, it is hereby announced that the assignment shall be acted upon.

It is further announced that every road and narrow path included in the said schedule for which no such case has been assigned before the expiry of the said three month period shall be deemed to be a road or narrow path owned by the Panduwasnuwara Pradeshiya Sabha(local council).
