#### **CUSTOMS NOTIFICATION**

Revenue Protection order No. 03/2023

REVENUE PROTECTION ACT, No. 19 OF 1962

Order

BY virtue of the powers vested in me under Section 2 of the Revenue Protection Act, No. 19 of 1962, I, Ranil Wickremesinghe, Minister of Finance, Economic Stabilization and National Policies of the Democratic Socialist Republic of Sri Lanka, do by this Order from July 01, 2023, require the Director General of Customs to demand and levy on each article specified in Column 3 of the Schedule hereto at the preferential import duty rate, which is leviable and payable under the Sri Lanka - Singapore Free Trade Agreement, set out in the corresponding entry in Column 4 of that Schedule as an integral part of the Schedule "A" of the Customs Ordinance (Chapter 235).

Import duty at the general rate set out in the corresponding entry in Column 5 or preferential rates set out in the corresponding entry in Column 4, which are leviable and payable on each article specified in Column 3 of Schedule "A" of the Customs Ordinance (Chapter 235), published in the *Extraordinary Gazette* No. 2324/49 dated March 24, 2023 as amended, including its Schedules are continued to remain in force without change.
