EXCISE (SPECIAL PROVISIONS) ACT, No. 13 OF 1989

Order under Section 3

BY virtue of the powers vested in me by Section 3 of the Excise (Special Provisions) Act, No. 13 of 1989, as amended, I, Ranil Wickremesinghe, Minister of Finance, Economic Stabilization and National Policies, do by this Order declare that, the rate of Excise Duty Specified in the Column IV applicable on corresponding articles specified in Column I, II and III of the Schedule hereto, shall replace the rate specified in Column IV on the corresponding articles of the Schedule I of the *Extraordinary Gazette* Notification No. 2312/68 dated December 31, 2022 issued under the Section 3 of this Act with effect from July 01, 2023.
