TOWN AND COUNTRY PLANNING ORDINANCE (CHAPTER 269)

Order under Section 6(2)(b) and Section 21(2)(b)

BY virtue of the powers vested in me by Section 6(2)(b) and Section 21(2)(b) of the Town and Country Planning Ordinance (Chapter 269), I, Prasanna Ranathunga, Minister of Urban Development and Housing do by this Order -

- declare that the area of land called "Meegammana Raja Maha Viharaya" specified in the Schedule hereto shall be an urban development area for the purpose of the aforesaid Ordinance ; and
- direct that an outline physical plan shall be prepared for the "Meegammana Raja Maha Viharaya" which is declared as above to be an urban development area.

SCHEDULE

The Area of Land Comprising Meegammana Raja Maha Viharaya

All that allotment of land depicted as Lot "A" in Survey General's Tracing No. Maha/PTD/2023/147 and dated 10th May 2023, of the land called "Vihare Waththa and Pihille or Deniya Kumbura" situated in the Village of Meegammana, in the No. 601 Meegammana Grama Niladhari Division, within in the Pallegampaha Korale, Minor Division in the Pathadumbara Divisional Secretariat Division in the District of Kandy in the Central Province, which the said allotment of land containing in extent of 1.5579 hectares (3 Acres, 3 Rood, 15.94 Perches) is bounded as follows -
