THE LAND ACQUISITION ACT AS AMENDED BY THE LAND ACQUISITION (AMENDMENT) ACT No. 28 OF 1964 (CHAPTER 460)

As the government intends to acquire the below mentioned land, required for the construction of the Wellawaya 33kv High Voltage Distribution Centre (Gantry Substation) proposed under the Supporting Electricity Supply Reliability Improvement Project (SESRIP—Package 1). It is hereby notified under Subsection 1of Section 7 of the Land Acquisition Act.
