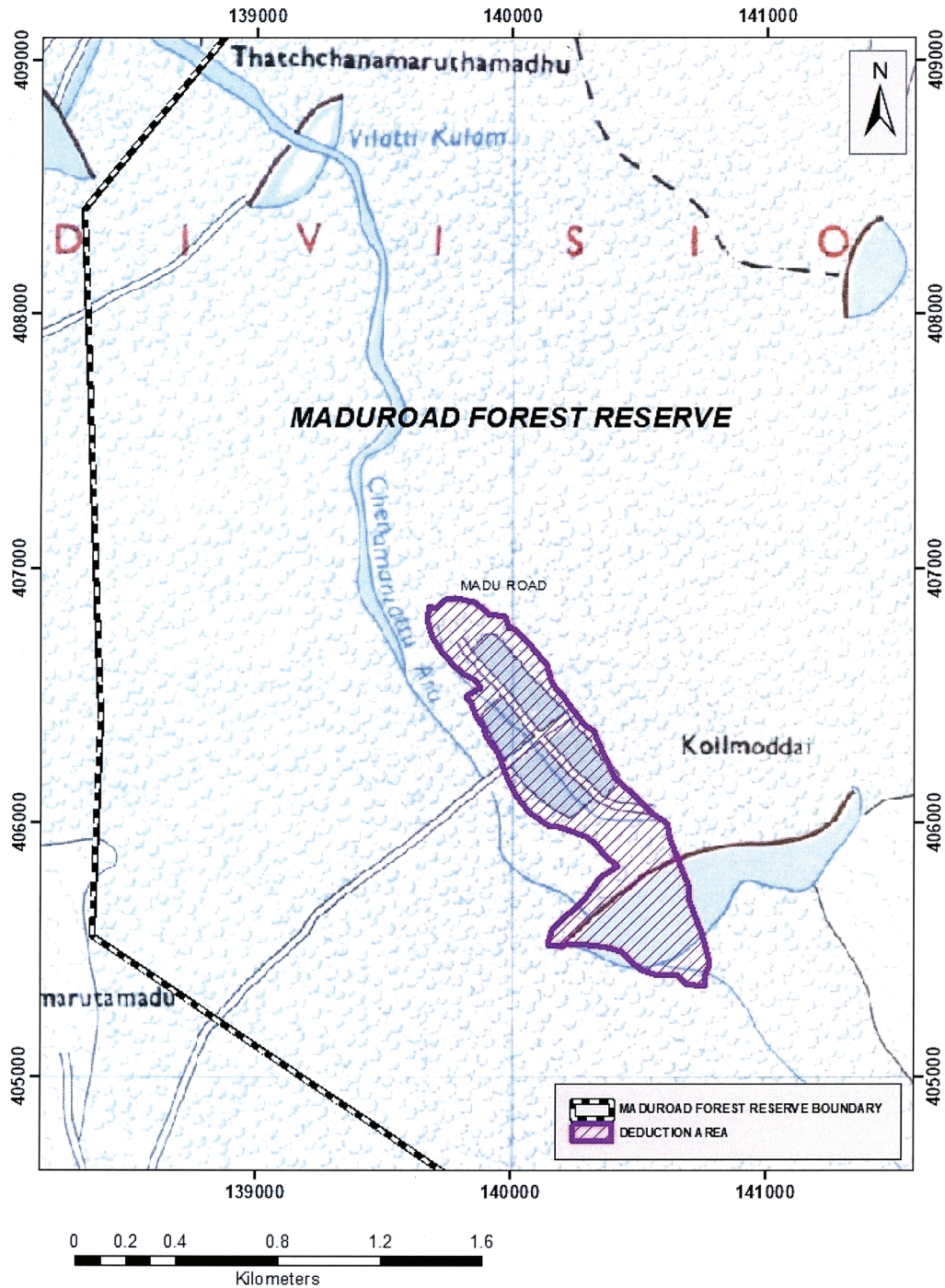
The Order
