#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Nalaka Jude Harin Fernando, Minister of Tourism and Lands do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

## THE LAND ACQUISITION ACT (CHAPTER 460)

### Declaration under Section 5

I, Nalaka Jude Harin Fernando, Minister of Tourism and Lands do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of lands in extent of 0.4589 hectare, depicted morefully is in the Advance Tracing No. Ka/MAD/2021/593, dated 15.06.2022, prepared by the Surveyor General, situated in the village called Warakagoda in Grama Niladhari Division No. 816 of Warakagoda - East in the Divisional Secretary's Division of Madurawala in Kalutara District of the Western Province and bounded as follows:
