#### THE UNIVERSITIES ACT, No. 16 OF 1978

#### Order under Section 27(1)(b) read with Sections 25A and 70C

BY virtue of the powers vested in me by section 27(1)(b) read with section 25A of the Universities Act, No. 16 of 1978, I, Dr. A. D. Susil Premajayantha, the Minister of Education, having obtained a report under section 70C of the aforesaid Act, in respect of the KAATSU - Highly Advanced Medical Technology Training Centre (Pvt) Limited (KIU), a company incorporated in Sri Lanka under the Companies Act, No. 7 of 2007 and bearing registration number PV 66705, which is recognised as a Degree Awarding Institute, and since under the certificate dated May 26, 2023 issued by the Registrar General of Companies the said KAATSU - Highly Advanced Medical Technology Training Centre (Pvt) Limited (KIU) has been incorporated as the KIU Campus (Private) Limited, do by this Order, amend the Order made under the said Act, and published in *Gazette Extraordinary* No. 1896/22 of January 7, 2015, by the substitution for the words "KAATSU-Highly Advanced Medical Technology Training Centre (Pvt) Limited (KIU)" wherever those words appear in the said Order, of the words "KIU Campus (Private) Limited" and every reference to the "KAATSU-Highly Advanced Medical Technology Training Centre (Pvt) Limited (KIU)" in any Order, notice, contract, communication or other document made in terms of the aforesaid sections shall be read and construed as a reference to the "KIU Campus (Private) Limited".

Further, any power exercised, or any duty or function performed by the said KAATSU-Highly Advanced Medical Technology Training Centre (Pvt) Limited (KIU) prior to the date of coming into effect of this Order in pursuance of any power conferred on it by the Order published in *Gazette Extraordinary* No. 1896/22 of January 7, 2015 shall be deemed for all purposes to have been validly exercised and performed by the KIU Campus (Private) Limited.
