TOWN AND COUNTRY PLANNING ORDINANCE (CHAPTER 269)

Order under Section 6(2)(b) and Section 21(2)(b)

BY virtue of the powers vested in me by section 6 (2) (b) and section 21 (2) (b) of the Town and Country Planning Ordinance (Chapter 269), I, Prasanna Ranathunga, Minister of Urban Development and Housing do by this Order -

- (a) declare that the area of land called "Sri Saddharma Yukthika Wana Senasuna" specified in the Schedule hereto shall be an urban development area for the purpose of the aforesaid Ordinance; and
- (b) direct that an outline physical plan shall be prepared for the "Sri Saddharma Yukthika Wana Senasuna" which is declared as above to be an urban development area.
