SPECIAL COMMODITY LEVY ACT, No. 48 of 2007

Order under Section 2 and Section 5

1. BY virtue of the powers vested in me under Section 2 of the Special Commodity Levy Act No. 48 of 2007, I, Shehan Semasinghe, Acting Minister of Finance, Economic Stabilization and National Policies of the Democratic Socialist Republic of Sri Lanka, do by this Order impose in respect of the commodity specified in Column I of the Schedule hereto a Special Commodity Levy at the rate specified in the corresponding entry in Column II of that Schedule.

By virtue of the powers vested in me by Section 5 of the Special Commodity Levy Act, No. 48 of 2007, do hereby make an Order to waive-off balance amount after collecting Rs. 1 per Egg from the applicable Special Commodity Levy of Rs. 50 per Egg on importation of Eggs, classified under the HS Code of 0407.21 listed out in the Schedule of the above by the Sri Lanka State Trading (General) Corporation on the recommendation of the Secretary, Ministry of Trade, Commerce and Food Security.
3. This Order shall be valid for a period of December 31, 2023 commencing from August 21, 2023 subject to provisions of Sub section (3) of Section 2 of the Special Commodity Levy Act, No. 48 of 2007.
