TRUSTS ORDINANCE (CHAPTER 87)

Order under Section 114

WHEREAS the Trustees of the "Joan De Mel Trust" namely -

- 1. Romesh De Mel;
- 2. Nalini Sirima Ellawala; and
- 3. Shaila Amalean,

have applied to the Minister of Justice, Prison Affairs and Constitutional Reforms for their incorporation under Section 114 of the Trusts Ordinance (Chapter 87)

Now therefore, by virtue of the powers vested in me by the aforesaid Ordinance, I, Dr. Wijayadasa Rajapaksha, Minister of Justice, Prison Affairs and Constitutional Reforms do by this Order authorize the incorporation of the said Trustees, and direct and declare that-

(a) The Trustees of the said Trust named above and their successors for the time being duly appointed under the Deed of Trust bearing No. 7304 of March 16, 1999 attested by Shelton Ernest Abeysuriya, Notary Public of Colombo, shall be a body corporate with perpetual succession and a common seal under the name and style of the "Joan De Mel Trust";

 - (b) the said Trustees may, under the said name and style purchase, receive, hold, take on loan or otherwise acquire, sell, exchange, mortgage, pledge, lease or otherwise dispose of any property movable or immovable, on behalf of the said Trust; and
 - (c) the said Trustees shall, by the said name and style, be able and competent in law to sue and be sued, to answer and to be answered, to defend and be defended, in any court in Sri Lanka or elsewhere in all cases and actions arising in relation to the said Trust.

This Order may be revoked, or from time to time be varied or amended in such manner as appear to me to be necessary.
