PUBLIC SERVICE COMMISSION

Delegation of Powers by the Public Service Commission in terms of Article 57(1) of the Constitution

BY virtue of the powers vested in terms of Article 57(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka, the delegation of powers made by the Public Service Commission by the *Gazette Notifications* published in the *Gazette Extra Ordinary* No. 2014/3 dated 11.04.2017 as amended by the *Gazettes Extraordinary* No. 2248/10 dated 04.10.2021, No. 2131/60 dated 13.07.2019, No. 2074/45 dated 08.06.2018 and No. 2043 /13 and 30.10.2017 shall be amended by addition of further delegation of powers as follows. These amendments shall come into effect from 02.01.2024.

By virtue of the powers vested in terms of Article 56(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka, the delegation of powers made by the Public Service Commission by the *Gazette Notification* published in the *Gazette Extra Ordinary* No. 2014/3 dated 11.04.2017 which was amended by the *Gazette Extraordinary* No. 2248/10 and 04.10.2021 by which the Public Service Commission delegated powers to the Education Service Committee is amended by addition of further delegation of powers as follows. These amendments shall come into effect from 02.01.2024.
