## THE ANTIQUITIES ORDINANCE (CHAPTER 188)

## **Order under Section 33**

BY virtue of the powers vested in me by Section 33 of the Antiquities Ordinance (Chapter 188), I, K. A. D. R. Nishanthi Jayasinghe, Director General of Archaeology, do by this notification declare with the approval of the Land Commissioner, that the area of state land specified in the Schedule, to this Notification, shall be an "archaeological reserve" for the purpose of the aforesaid Ordinance.

#### **SCHEDULE**

### Area Reserved for Archaeological Purposes of Kiralagala

All that allotments of land containing in extent of Fifty Two decimal Seven Nine Eight Nine Hectares (52.7989 Hectares) depicted as Lot A in tracing No. Aa/DSO/2020/359 dated 15.12.2020 of the lands are consisting of the parts of the final village plan Nos. 1373, 1382, 1387 surveyed and made by the Surveyor General of Land called Millagahahena *alias* Nugagahawatte situated in the Village Agunochchiya in Grama Niladhari's Division No. 119 in Ihala Agunochchiya in Horowpathana Divisional Secretary Division in Anuradhapura District in the North Central Province and bounded and consist of land as follows:
