THE ANTIQUITIES ORDINANCE (CHAPTER 188)

Notification under Section 33

BY virtue of the powers vested in me by Section 33 of the Antiquities Ordinance (Chapter 188), I, K. A. D. R. Nishanthi Jayasinghe, Director General of Archaeology, do by this notification declare with the approval of the Land Commissioner, that the area of state land specified in the Schedule, to this Notification, shall be an “archaeological reserve” for the purposes of the aforesaid Ordinance.

## SCHEDULE

**Area Reserved for Archaeological Purposes of Beligala Rock**

All that divided and defined allotments of land marked Lot 1 depicted in Preliminary Plan No. Ke. 2785 (RD No. 53/24 (1/23 4A)) dated 10.09.1998 surveyed and made by the Surveyor General of the land called Beligala Rock situated in Beligala Village in the Grama Niladhari's Division of No. 81A of Kumbalgama in Divisional Secretary Division, Warakapola in Beligal Korale / Othara Pattu in Kegalle District in the Sabaragamuwa Province and bounded as follows:

*On the North :* Land called Gal Asse Hena, Thembiliyadda and Ethulwatta claimed by Senanayake family and Udalagama Family;

*On the East :* Land called Ethuluwatta, Elhena Road claimed by Senanayake family and Udalagama family and land called Alhena claimed by Senanayake family and Udalagama family and Walawwatta claimed by T. M. Sathyarathne;

*On the South :* Walawwatta claimed by T. M. Heen Manike and L. Rupasinghe and Udaha Walawwa claimed by S. M. Gunawardana and coconut land called Aswedduma claimed by Senanayake family and Udalagama family;

*On the West :* Coconut land called Aswedduma claimed by Senanayake family and Udalagama family, and land called Galassehena Thembiliyadda claimed by Senanayake family and Udalagama family.
