THE ANTIQUITIES ORDINANCE (CHAPTER 188)

Notification under Section 33

BY VIRTUE of the powers vested in me by section 33 of the Antiquities Ordinance (Chapter 188), I, K.A.D.R. Nishanthi Jayasinghe, Director-General of Archaeology, do by this notification declare that the area of state land specified in the Schedule with the approval of the Land Commissioner, to this Notification, shall be an “archaeological reserve” for the purposes of the aforesaid Ordinance.

AREA RESERVED FOR ARCHAEOLOGICAL PURPOSES OF MUHUDU MAHA VIHARAYA
