Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Nalaka Jude Harin Fernando, Minister of Tourism and Lands do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Allotments of land depicted in below names and extents in the Advance Tracing No. CO/DSO/2021/05 dated of 14.11.2022 prepared by the Surveyor General, situated in the Village called Pepiliyana (within the Urban Council limits of Boralesgamuwa) in the Grama Niladhari Division No. 535 of Pepiliyana West in the Divisional Secretary's Division of Kesbewa in Colombo District of the Western Province and bounded as follows:

01. Lot 'A' – Madangahaowita *alias* Bakmeegahaowita – Extent: 0.0114 Hectare

North: Lands bearing Assmt. Nos. 465/23A, 327/6, 327/5, 327/4C, 327/4, 327/3, 327/2A and 327/2; East: Lands bearing Assmt.
