I hereby give notice under Sub section (1) of Section 7 of the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government has acquired the below mentioned land to develop the drainage system at Aththidiya Wewa road under Greater Colombo Flood Control and Environment Improvement Project:

Description of the land to be acquired:

An allotment of land in total extent of 0.0147 hectare depicted as lot number 01 in the preliminary plan no. 9366 dated 04.07.2013 prepared by the Surveyor General, situated in Village called Aththidiya in the Grama Niladhari Division of Aththidiya in the Divisional Secretary's Division of Dehiwala in Colombo District of the Western province and bounded as follows.

Name of the Land: Aththidiya Paddy field;
Description: Cement drain; Claimant: State; Extent: 0.0147 Hectare.
