GRANTING PERMISSION BY VIRTUE OF POWERS VESTED IN ME UNDER SECTION 27(A) OF PROVINCIAL COUNCIL ACT, No. 42 OF 1987 AS THE TERM OF THE SIXTH SABARAGAMUWA PROVINCIAL COUNCIL OF THE DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA ENDED ON 26TH SEPTEMBER, 2017.

- 1. This permission may be cited as "Permission to disburse under the fourth supplementary financial statement 2024 of the Sabaragamuwa Provincial Council" and come in to operation from 16.08.2024.
- 2. The expenditure of the Sabaragamuwa Provincial Council which is estimated Rupees Fifty Two Billion Three Hundred and Eighty Four Million Eight Hundred and Thirty Three Thousand Four Hundred and Forty Eight and Cents Forty only (Rs. 52,384,833,448.40) for the service of the period beginning on 01st of January, 2024 and ending 31st December 2024, which is specified as "Financial Year 2024" in the Annual Financial Statement and Revenue Expenditure Estimates prepared for the year 2024, is hereby amended as, Rupees Fifty Two Billion Eight Hundred and Senenty Two Million Four Hundred and Thirty Eight Thousand One Hundred and Senenty One and Cents Eighty Two only (Rs. 52,872,438,171.82) and grant permission to the Chief Secretary of this Province and other Accounting Officers to disburse the same from the Sabaragamuwa Provincial Council Fund.



- 3. Accordingly the first schedule of the Annual financial statement and revenue- expenditure estimates- 2024, is amended as the first schedule hereof and grant permission to disburse the same.
- 4. The limits of the advanced accounts in second schedule of Revenue and Expenditure Estimates of the year 2024, is hereby amended as second schedule of this notification.
- 5. This permission will be valid till 31st of December, 2024 or upto the date that expires three months (03) from the date of summoning the Seventh (07th) Sabaragamuwa Provincial Council or from the date re-start the functions of the Sabaragamuwa Provincial Council which occurs first.
