THE LAND ACQUISITION ACT (CHAPTER 460)

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose :

Description of the Land to be acquired :

Two allotments of land marked as Lot Nos. 01 and 02 in Total Extent of 0.8545 Hectare and depicted in Cadastral Map No. 810343 of 15.08.2024 made by the Survey Superintendent, situated in the Village of Imaduwa, in the Divisional Secretary's Division of Imaduwa, District of Galle, Southern Province and the description of the allotment of lands are as follows :-
