The matter in dispute between the aforesaid parties is

Whether Mr. W.K.K. Jayantha who worked in the Sri Lanka Transport Board had been caused injustice by.

1. not being paid an allowance for cover up/ acting duties in the post of Civil Engineer Grade III B from 15.05.2012 to 06.02.2019 if entitled,
2. not being paid an allowance for cover-up/ acting duties in the Post to Chief Civil Engineer from 07.02.2019 to 10.04.2021 if entitled and
3. not being paid the monthly allowance of Rs. 10,000/= paid to other Divisional Heads for the post of Chief Civil Engineer which is Major Divisional Post of the Sri Lanka Transport Board

and if such injustice had been caused, to what relief he is entitled.
