REVOCATION of directions and the rule relating to deposit solicitation by Finance Companies issued under the Finance Companies Act, No. 78 of 1988.

The public is hereby informed that the Governing Board of the Central Bank of Sri Lanka has decided to revoke the following directions and the rule issued under the Finance Companies Act, No. 78 of 1988, with effect from 21st November, 2024, subsequent to issuance of the Finance Business Act (Deposit Solicitation by Finance Companies) Direction No. 03 of 2024 under the Finance Business Act, No. 42 of 2011:

1. Finance Companies (Deposits) Direction No. 01 of 2005 – This Direction was issued by the Monetary Board on 31st January, 2005 under the Finance Companies Act, No. 78 of 1988 and published in the *Government Gazette* (*Extraordinary*) No. 1378/12 dated 01st February 2005.
