#### Order under Section 20(5)

ACTING under the powers vested in it by Section 20 (5) of the Consumer Affairs Authority Act, No. 09 of 2003, the Consumer Affairs Authority orders that no Manufacturer, Producer, Supplier, Distributor or Trader shall Sell, Supply, Expose or Offer for sale, Display for sale the Local varieties of Rice listed below, exceeding the Maximum Prices given hereunder.

Variety	Maximum Wholesale Price	Maximum Retail Price
White/Red Raw Rice - Local	Rs. 215/- per kg	Rs. 220/- per kg
White/Red Nadu Rice - Steamed /Boiled - Local (excluding Mottaikarupan and Attakari)	Rs. 225/- per kg	Rs. 230/- per kg
White/Red Samba Rice - Raw and Steamed /Boiled - Local (excluding Suduru Samba)	Rs. 235/- per kg	Rs. 240/- per kg
Keeri Samba Rice- Raw and Steamed/ Boiled - Local	Rs. 255/- per kg	Rs. 260/- per kg
