GRANTING PERMISSION BY VIRTUE OF POWERS VESTED IN ME UNDER SECTION 27(A) OF PROVINCIAL COUNCIL ACT NO. 42 OF 1987 AS THE TERM OF THE SIXTH SABARAGAMUWA PROVINCIAL COUNCIL OF THE DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA ENDED ON 26TH SEPTEMBER, 2017.

1. This permission may be cited as “Permission to disburse under the sixth supplementary financial statement - 2024 of the Sabaragamuwa Provincial Council” and come in to operation from 30.10.2024.
2. The expenditure of the Sabaragamuwa Provincial Council which is estimated Rupees Fifty Three Billion Three Hundred Million Nine Hundred and Forty Three Thousand Sixty Eight and Cents Eighty Two only (Rs. 53,300,943,068.82) for the service of the period beginning on 01st of January, 2024 and ending 31st December 2024, which is specified as “Financial Year 2024” in the Annual Financial Statement and Revenue- Expenditure Estimates prepared for the year 2024, is hereby amended as, Rupees Fifty Four Billion Three Hundred Forty Three Million Four Hundred and Twenty Eight Thousand Two Hundred Twelve and Cents Seventy Three only (Rs. 54,343,428,212.73) and grant permission to the Chief Secretary of this Province and other Accounting officers to disburse the same from the Sabaragamuwa Provincial Council Fund.



3. Accordingly the first schedule of the Annual financial statement and revenue- expenditure estimates- 2024, is amended as the first schedule hereof and grant permission to disburse the same.
4. The limits of the advanced accounts in second schedule of Revenue and Expenditure Estimates of the year 2024, is hereby amended as second schedule of this notification
