I hereby give notice, under Sub section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964 that the Government intends to acquire the following land, which is required for a public purpose :

Description of the lands to be acquired :

An allotment of land extended 3.9975 Hectares, mentioned in the Preliminary Survey plan bearing No. GAM. 4229 dated 26.01.2021, prepared by Senior Superintendent of Surveys, Gampaha instead of Surveyor General, situated in the Village of Welikadamulla in Walikadamulla Grama Niladhari Division, No. 363, in Attanagalla Divisional Secretary's Division in Gampaha District, Western Province.

N.B.— Since, it has been decided to redemption the plot of land called Lot No. 14 in the Preliminary Survey plan bearing No. GAM. 4229, under the Section No. 39 (a), 0.9314 Hectares has been deducted out of the whole extend of 4.9289 Hectares of the plan.
