#### THE LAND ACQUISITION ACT (CHAPTER 460)

#### **Declaration under Section 5**

I, Nalaka Jude Harin Fernando, Minister of Tourism and Lands, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is required for a public purpose and will be acquired under the provisions of the said Act.

The allotments of Land described as following names and extent, depicted in the Advance Tracing No. Maha/KND/2019/351 dated 18.12.2019 prepared by the Surveyor General, situated at the Village of Menikhinna (Udagammedda), in Menikhinna Grama Niladhari Division, No. 705, in Udagampaha Korale Minor Division, in the Divisional Secretary's Division of Kundasale in Kandy District, in Central Province and boundaed as follows:
