THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 7

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, As Amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following lands/ Servitudes which are required for a public purpose:

*Description of the land/servitude sought to be acquired:-*

1.8820 hectares from the total land depicted as Lot No. 1, 2 and 3 in Paper No. 1, Zone No. 04 of 27.12.2023 dated Plan No. C.P. 820414 prepared by Surveyor General and situated in the village of Mulatiyana and Neralampitiya in the Neralampitiya Grama Niladhari Division in Mulatiyana Divisional Secretary's Division in Matara District, Southern Province.
