All the land bounded by metes and bounds in Column II the area of land comprising the following Grama Niladhari Divisions of the Hanguranketha Pradeshiya Sabha within the Hanguranketha Divisional Secretariat in Nuwara Eliya District, Central Province No. 494 Damunumeya Grama Niladhari Division, No. 495 Hanguranketha Grama Niladhari Division, No. 494E Damunumeya North Grama Niladhari Division, No. 495D Delgahapitiya Grama Niladhari Division, No. 496B Arattana Grama Niladhari Division, No. 492C Walalawela Grama Niladhari Division, No. 493 Madanwela Grama Niladhari Division, No. 495C Pallemaluwa, Part of No. 495A Pussalamankada Grama Niladhari Division, Part of No. 492 Diyaudagama Grama Niladhari Division, Part of No. 493A Kottala Grama Niladhari Division and Part of No. 495B Yati Hanguranketha Grama Niladhari Division.

North:

Commence from the center line of the George Abheyygunasekara Mawatha which take as the starting point, which meets the northern boundary of No. 495D Delgahapitiya Grama Niladhari Division and the South-eastern boundary of No. 495A Pussalamankada Grama Niladhari Division (01), thereafter towards South-East wards along North boundary of the No. 495D Delgahapitiya Grama Niladhari Division (02) and then towards South-East wards along center line of the Hanguranketha - Adhikarigama road until it meets of North boundary of No. 495 Hanguranketha Grama Niladhari Division (03), from thereafter towards South, South-east direction along the boundary of the same Grama Niladhari Division until it meets the point of No. 493A Kottala Grama Niladhari Division (04),

East:

From the last- mentioned point, towards the North, Northeast wards along the boundary of No. 493A Kottala Grama Niladhari Division and from thereafter towards South, Southwest, Southeast direction along center line of the Kottala road until it reaches mid- point of the No. 492 Diyaudagama Grama Niladhari Division (05) in Northeast wards, from there the line running through the mid line of the Walugama road towards South, East, Southeast and Southwest wards until it meets Southeast boundary of No. 492C Walalawela Grama Niladhari Division (06), from there, towards the line drawn in a South-east, South-west direction in No. 492C Walalawela Grama Niladhari Division to the point where it meets the intersecting mid- point of Thannekumbura-Rikillagaskada-Ragala main road (B413) (07), after then towards Southwest, Northwest wards along West boundary of No. 492C Walalawela Grama Niladhari Division up to the point of No. 493 Madanwela Grama Niladhari Division (08) where it meets the Southern boundary.

Total land area comprising of in addition to Grama Niladhari Divisions of No. 1085 Nawalapitiya East, No. 1088 Nawalapitiya West, No. 1087 Nawalapitiya North, No. 1086 Nawalapitiya South, and parts of No. 1105 Warakawa, No. 1083 Bawwagama, No. 1084 Imbulpitiya Grama Niladhari Divisions belonging to the Nawalapitiya Urban Development area of the Kandy District, which had been declared as an Urban Development area under & by virtue of the *Extra Ordinary Gazette Notification* No. 100/4 dated 1980.08.04 of the Democratic Socialist Republic of Sri Lanka, Grama Niladhari Divisions of No. 1107 Karahandungala, No. 1097 Kendopitiya, No. 1104 Pallegama, No. 1096 Weligampola, No. 1102 Weligodawaththa, and remaining parts of No. 1105 Warakawa, No. 1083 Bawwagama Grama Niladhari Divisions described in column II hereof.

Total land area, commencing from the point where the Western and Northern boundary of No. 1102 Weligodawatta Grama Niladhari Division meet and henceforth along the Northern boundary of said Grama Niladhari Division towards East direction up to the point where it meet the Northern boundary of No. 1104 Pallegama Grama Niladhari Division and thence, along the northern boundary of said Grama Niladhari Division towards the East direction by intersecting the Gampola - Nawalapitiya road (AB13) until the point where it meets the center line of Mahaweli River,
