THE JUDICATURE ACT, No. 2 of 1978

Order under Section 3

BY virtue of the powers vested in me by section 3 of the Judicature Act, No. 2 of 1978, 1, Dr. Wijeyadasa Rajapakshe, Minister of Justice, Prison Affairs and Constitutional Reforms in consultation with the Chief Justice and the President of the Court of Appeal, do, by this Order, amend the Schedule to the Order made under section 3 of the said Act and published in the *Gazette Extraordinary* No. 1679/40 of November 10, 2010 (as last amended by Order published in the *Gazette Extraordinary* No. 2199/17 of October 29, 2020) as follows:-
