I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the below mentioned land has to be acquired to the Government to avoid the difficulties that will occur when constructing access roads to the houses and the hindrances that will be caused when the maintenance activities are carried out at the end of the New Mutwal Tunnel Project which is being constructed under the Metro Colombo Urban Development Project.

Description of the land or Servitude to be acquired:

Allotments of land in total extent of about 0.0149 hectare, depicted as Lot Nos. 1 to 8 in Sheet No. 01 in Block No. 04 of the Cadastral Map No. 520406 dated 15.03.2024 prepared by the Surveyor General, situated in the village
