THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Nalaka Jude Harin Fernando, Minister of Tourism and Lands do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of below mentioned lands depicted in the Advanced Tracing No. R/AYG/2021/47 and dated 09.08.2021 prepared by the Surveyor General, situated in the Village called Dumbaragama (F.V.P. 52) in the Minor Division of Palle Paththuwa in the Divisional Secretary's Division of Kukulu Koralaya, Ayagama of Ratnapura District of Sabaragamuwa Province and bounded as follows:

01. Lot 'A' – Dumbara Waththa, Kaluwanahena – Extent: 0.0576 Hectare

Declaration under Section 5
