Kandy Municipal Council - Entertainment Tax

I, Lalith U. Gamage (Attorney-at-law), Governor of Central Province, as per the powers vested in me under Sub-section 2 (2) of the Entertainment Tax Ordinance to be read with section 2 (1) (a) of the Provincial Council (Consequential Provisions) Act No. 12 of 1989, hereby announce that the notification published in the *Extraordinary Gazette* No. 2335/04 dated 05.06.2023 of the Democratic Socialist Republic of Sri Lanka, adopted by the Kandy Municipal Council on 31.10.2022 as per the provisions mentioned under Sub-section (I) of section 2 of the Entertainment Tax Ordinance No. 12 of 1946 (267th Authority) as amended by the Entertainment Tax (Amendment) Act No. 37 of 1984 and approved by me, is amended as in the Schedule hereto as per the resolution passed under decision No. 2023/408 at the Management Committee Meeting of the Kandy Municipal Council held on 16.08.2023.

## RESOLUTION

I hereby propose to levy an entertainment tax of 7.5% from 01st January 2024 on the face value of admission tickets for entertainment activities and for every chargeable activity mentioned in the following schedule. According to section 2 (1) of the Entertainment Tax Ordinance No, 12 of 1946 and the Entertainment Tax Amendment Act No. 37 of 1984, for levy of entertainment tax in Kandy Municipal Corporation area, as per the powers vested in me by the Municipal Council Ordinance No. 16 of 1947.

Furthermore, I hereby announce that this percentage shall be considered as the entertainment tax percentage for all activities mentioned in this schedule and for every chargeable activity, until a new order is made in this regard.
