THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

- I, Nalaka Jude Harin Fernando, Minister of Tourism and Lands, do hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No: 28 of 1964, that the servitude described below is needed for a public purpose and will be acquired under the provisions of that Act.
