DECISION

In terms of the powers conferred on the Secretary of the Welivitiya Divithura Pradeshiya Sabha by Sub-section (1) of the second section of the Entertainment Tax Ordinance Act No. 12 of 1946 (being the 267th Authority) to be read with section 9 (3) of the Pradeshiya Sabha Act No. 15 of 1987. to levy an amount equal to 10% (Ten percent) of a payment made to any entertainment activity described in the above mentioned Entertainment Tax Ordinance conducted in the areas within the administrative limits of the Welivitiya Divithura Pradeshiya Sabha as a Tax and that this decision shall be effective from the date of its publication in the Government *Gazette*. Furthermore, I also decide that the entertainment Tax levied above should be properly paid to the Welivitiya Divithura local council by the relevant organizer or organizers before the day of the said entertainment.
