Declaration under Section 5

I, Nalaka Jude Harin Fernando, Minister of Tourism and Lands, hereby declare that under Sub-section (1) of Section 5 of the Land Acquisition Act, Servitude described below are required for a public purpose and will be acquired under the provisions under Land Acquisition Act.
