SCHEDULE 1

ORDER UNDER SECTION 39A(1)

AN allotment specified in the Order No. 222 of 1983 made under the Proviso (a) to Section 38 of the Land Acquisition Act (Chapter 460) and published in the *Gazette Extraordinary* No. 261/3 dated 05th September 1983 are vested absolutely in the State and the possession of which have been taken for or on behalf of the State under Para (a) of Section 40 of the aforesaid Act. But by the virtue of powers vested in me by sub section (1) of Section 39(a) (inserted by Act, No. 8 of 1979) of the Land Acquisition Act, I, Nalaka Jude Harin Fernando, Minister of Tourism and Lands, do hereby divest only the allotment described in the Schedule I below.
