##### THE LAND ACQUISITION ACT (CHAPTER 460) Declaration under Section 5

I, Nalaka Jude Harin Fernando, Minister of Tourism and Lands hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of land called Viharawatta in extent of about 3.8868 Hectares in depicted Lots A and B in Advance Tracing No. KA/PLN/2020/396 prepared by Surveyor General dated 29.06.2022 situated in the village of Viharagama in the Divisional Secretary's Division of Palindanuwara in Kalutara District and bounded as follows:
