THE COLOMBO PORT CITY ECONOMIC COMMISSION ACT, No. 11 OF 2021

Order under Section 53

BY VIRTUE of the powers vested in me by Section 53 of the Colombo Port City Economic Commission Act, No. 11 of 2021, I, Ranil Wickremesinghe, Minister of Investment Promotion, having considered the recommendations of the Colombo Port City Economic Commission and upon the approval of the Cabinet of Ministers, do by this Order specify that-

- (a) the Cabinet of Ministers, by its decision No. 24/1315/631/034 dated, July 09, 2024 has approved the designation of the business of the authorised person specified in Schedule I hereto as a Business Strategic Importance Duty Free Retail Operations;
- (b) the rationale for considering such business as a Business of Strategic Importance Duty Free Retail Operations is as specified in Schedule II hereto;
- (c) the exemptions or incentives granted under the enactments shall be as specified in Schedule III hereto; and
- (d) the exemptions or incentives granted under the enactments specified shall commence and cease to be operative on the dates specified in Schedule IV hereto.

SCHEDULE II

Rationale for the consideration of the Business of Strategic Importance - Duty Free Retail Operations

The objectives of the Colombo Port City Economic Commission, as stated in Section 5 of the Colombo Port City Economic Commission Act, No. 11 of 2021 has been considered in designating the businesses as Business of Strategic Importance - Duty Free Retail Operations in order to ensure the success of establishing the Colombo Port City, having regard to the national interest or in the advancement of the national economy as stated in Section 53(5) of the said Act.

The Applicant is a Joint Venture (JV) of 80:20 between China Duty Free International Limited of Hong Kong and CHEC Port City Colombo (Pvt) Ltd, established, to engage in the business of Duty-Free Retail Operations with an investment of USD 10.9 million which exceeds the minimum investment qualification criteria of USD 5 million and initially generate approximately 50 employment opportunities. The main JV partner China Duty Free International Limited is a world leading travel retailer consisting of more than 200 stores worldwide, with an annual turnover of USD 10.5 billion in 2021 and in collaboration with more than 1000 global top brands with over 20 million loyalty members.
